



- 4 FUNDING SOURCE REVIEW**
For each source undertake SWOT analysis drawing on external and internal reviews. Prioritize initiative. Set out implementation approach for each priority.
- 5 TARGETS AND RESOURCE REQUIREMENTS**
Decide on resources and for BMT set targets. Utilise all research and consider all relevant factors to inform implementation approach.
- 6 ACTION PLAN**
Break all implementation actions with descriptions, timelines and targets. Update constituency, review and regular measure with BMT.




